Dear Supervisor Marceron,

Thank you for the opportunity to comment on the Proposed Revised Land Management Plan (PRLMP) for the Chugach National Forest. Alaska Wilderness League works to preserve wild lands and waters in Alaska by engaging citizens and decision makers alike. In Alaska, our organization has a growing network of residents who care deeply about the longevity and productivity of wilderness areas in all regions of the state.

First, we want to commend the Forest Service for acknowledging, in the first paragraph of the revised plan, that "the Chugach National Forest has played an important role in shaping the environment, cultures, customs, and economies of southcentral Alaska." We couldn't agree more with this statement. However, we believe two changes to the PRLMP are necessary to ensure that the forest continues to provide for Alaska residents, both today and long into the future:

- 1. The Forest Service should revise its recommendation for the Wilderness Study Area (WSA), so that the entirety of the original 1.9 million acre WSA is recommended for Wilderness designation.*
- 2. Until Congress acts on the WSA recommendation, the Forest Service should strengthen the Management Plan to highlight and explain how management standards of the WSA will match those of federally designated Wilderness. This includes keeping language from the 2002 plan, which cites the Wilderness Act and Regional Manual and the Alaska National Interest Lands Conservation Act (ANILCA) as guiding documents. The current draft only references ANILCA, which leaves the management directive unclear.*

I'd like to begin by asserting that the WSA should be managed with the highest of standards, that of the Wilderness Act of 1964 with applicable ANILCA provisions. All areas within the WSA should be classified as "Primitive."

I also urge that Congress designate the entire WSA as Wilderness designation with Knight Island, Columbia Glacier, Perry Island, Esther Island, Port Wells, College Fiord, Lake Nellie Juan, and the mainland along Knight Island added to those lands already included in the 2002 recommendation.

The Copper River/Bering River area should be protected.

The Forest should be withdrawn from mineral and forestry activity with additional protective acquisitions being identified.

Additional Wild and Scenic River designations should be recommended.

It is critical that the Exxon Valdez Oil Spill (EVOS) Restoration mandate for the region be upheld.

Finally, I support additional non-motorized areas for inclusion on the Kenai Peninsula.
